The High Commission of the Republic of Maldives in Malaysia hereby confirms that the Maldivian driving license will be recognized in Malaysia effective from Monday, 12th September 2022 following the signing of Mutual Recognition Agreement between the Government of Malaysia and the Government of Maldives (MRA) on 12th August 2022. The following categories of vehicles will be allowed in Malaysia in accordance with Article 3 of the MRA. There is no requirement to verify the driving license from the High Commission of Maldives. Motorists are advised to print and carry a copy of this announcement letter.

Suruhanjaya Tinggi Republik Maldives di Malaysia mengesahkan bahawa lesen memandu Maldives akan diiktiraf di Malaysia berkuat kuasa mulai Isnin, 12 September 2022 berikutan pemeteraian Perjanjian Pengiktirafan Bersama antara Kerajaan Malaysia dan Kerajaan Maldives (MRA) pada 12 Ogos 2022. Kategori kenderaan berikut akan dibenarkan di Malaysia mengikut Perkara 3 MRA. Pemandu kenderaan dinasihatkan untuk mencetak dan membawa salinan pengumuman ini. Oleh itu, lesen memandu Maldives tidak memerlukan pengesahan daripada Suruhanjaya Tinggi Maldives.

Malaysia dan Republik Maldives akan mendapat pengiktirafan bersama lesen memandu domestik yang dikeluarkan oleh setiap negara, berkuatkuasa mulai Isnin, 12 September 2022.

Ini merupakan Perjanjian Pengiktirafan Bersama (MRA) dua hala pertama Malaysia dengan negara asing.

Melalui MRA ini, rakyat kedua-dua negara boleh terus menggunakan Lesen Memandu domestik masing-masing dan memandu kenderaan bermotor yang dibenarkan di negara masing-masing tanpa perlu melalui proses bagi mendapatkan atau membuat sebarang pertukaran lesen memandu.

MRA ini akan memberi kemudahan kepada rakyat kedua-dua negara yang sekaligus dapat menyumbang kepada pembangunan sektor sosial dan ekonomi Malaysia serta Republik Maldives.

Saya ingin mengucapkan terima kasih kepada Menteri Pengangkutan dan Penerbangan Awam Maldives, Puan Yang Terutama, Aishath Nahula kerana sudi hadir untuk menandatangani MRA bersama saya di Kementerian Pengangkutan (MOT) hari ini. Saya amat berbesar hati mengalu-alukan kedatangan beliau dan delegasi termasuk Timbalannya, Tuan Yang Terutama, Encik Ahmed Zuhair serta Timbalan Pesuruhjaya Tinggi Maldives ke Malaysia, Puan Yang Terutama, Uz. Mariyam Mizna Shareef. Selepas menandatangani perjanjian tersebut, kami mengadakan majlis resepsi untuk mereka di sebuah restoran di Putrajaya.

Kami berharap akan mempunyai lebih banyak peluang untuk bekerjasama dengan Maldives khususnya dalam sektor pengangkutan.

Malaysia and the Republic of Maldives will have a mutual recognition of domestic driving licenses issued by each country, effective from Monday, 12 September 2022.

This is Malaysia's first bilateral Mutual Recognition Agreement (MRA) with a foreign country.

Through this MRA, citizens of both countries can continue to use their domestic driving license and drive authorized motor vehicles in their respective countries without going through the process of obtaining a new driving license or converting the existing driving license.

This MRA will facilitate citizens of both countries who can then ultimately contribute to the development of the social and economic sectors of both Malaysia and the Republic of Maldives.

I would like to thank Maldives Minister of Transport and Civil Aviation, Her Excellency Aishath Nahula for attending the MRA signing with me at Ministry of Transport (MOT) today. It is my immense pleasure to welcome her arrival and the delegation including the State Minister of Maldives Transport Ministry His Excellency, Mr. Ahmed Zuhair as well as Deputy High Commissioner of Maldives to Malaysia, Madam, Uz. Mariyam Mizna Shareef. Following the signing of the agreement, we held a reception for them at a restaurant in Putrajaya.

We hope to have more collaborative arrangements in the transport sector with the Maldives.
